A summary of the duties include:

- Receive and accession physical evidence while maintaining legal chain-of-custody and integrity of submitted specimens.
- Process various biological specimens that include human blood, oral swabs, cadaveric tissues, teeth, and/or bone.
- Prepare reagents used in forensic analyses.
- Quantify DNA extracted from evidence samples.
- Generate data using PCR-based methods (mtDNA sequencing and/or STR typing).

- A Bachelor's degree in Forensic Science or one of the natural sciences.
